MESSAGE FROM REP. CÁRDENAS

Since first being elected to office – from the State Assembly to the LA City Council and now in Congress – one of my main goals has been to promote public safety with law enforcement collaboration for fair, smart-on-crime policies for youth opportunity and justice through all aspects of the justice system.

Growing up in Pacoima, I witnessed the long-lasting effects of our broken criminal and juvenile justice systems. I saw how systemic problems keep

young Americans in a perpetual cycle of incarceration. We all make mistakes when we're young, but those mistakes should not determine our futures. American children belong in schools, not in prisons, and everyone deserves a **second chance**.

In 2000, as a California State Assemblyman, I co-authored and passed the Schiff-Cárdenas Juvenile Justice Crime Prevention Act which has provided local communities with approximately \$120 million per year, the single, largest appropriation of state funds for youth crime prevention in the history of the United States. Confirming its effectiveness, a report from the Rand Corporation indicates that statewide efforts after the passage of the Schiff-Cárdenas Act have resulted in lower law enforcement costs and a measurable positive effect on young people who participate in it.

Now in Congress, I'm leading the **Second Chance for Justice legislative package** because I believe our children deserve to live in a world where they can change for the better, and where their future is not be defined by a single mistake. That is the world I am fighting for every day.

WHY WE NEED A SECOND CHANCE FOR JUSTICE LEGISLATIVE PACKAGE

The U.S. invests more in keeping children in prison than any other country in the industrial world. For too long, we have relied on a juvenile justice model that prioritizes wasteful incarceration over efficient, effective rehabilitation. The United States has the highest youth incarceration rates of any developed nation.



Each year, 76,000 of America's youths are tried or sentenced as adults – most of whom are prosecuted for nonviolent offenses. Children under the age of 18 are not allowed to vote, yet in many states, children as young as seven can be tried as adults. We know that locking up children does not reduce crime or the rate of juvenile recidivism. Youth incarceration has the opposite effect. While incarcerated, children are often provided with inadequate education instruction, health care and counseling services and are at greater risk of maltreatment, physical and psychological abuse, sexual assault and suicide.

Given the current climate, bold juvenile and criminal justice reform have never been more important. The Second Chance for Justice Package Includes three legislative bills that aim to reform the criminal and juvenile justice system by protecting children during police interrogations; supporting community-based organization and their work to further evidence-based prevention and intervention initiatives for at-risk youth that reduce crime in communities and implement smart youth justice alternatives; and eliminating the practice of collecting juvenile fines and fees that are harmful to children and families.

BY THE NUMBERS

While the number of children arrested and incarcerated has declined in recent years, America's children continue to be criminalized at alarming rates. Many children—particularly children in poverty, children of color, children with disabilities, children with mental health and substance abuse challenges, children abused or neglected, children in foster care and LGBTQ children—are pushed out of their schools and homes into the juvenile justice or adult criminal justice systems.

PROTECTING MIRANDA RIGHTS FOR KIDS ACT

THE PROBLEM:

Research shows that children waive their Miranda rights at extremely high rates, with several studies putting it at roughly 90 percent. Children are much more likely than adults to make false confessions. A study of exonerations found that 42 percent of exonerated children had falsely confessed, compared with 13 percent of adults. The American Academy of Children and Adolescent Psychiatry recognizes that children's brain



development, specifically the area related to reasoning, continues to mature well into early adulthood and that children should have an attorney present during questioning by police or other law enforcement agencies. The cases known as the Central Park Five are one of hundreds of cases of proven false confessions resulting in minors who falsely confess, get convicted and end up spending years in prison. Sadly, these kinds of cases continue to happen today.

THE SOLUTION:

The **Protecting Miranda Rights for Kids Act** seeks to protect children during police interactions and ensures their due process Constitutional Rights are upheld by requiring law enforcement to notify and contact parents or guardians in the event a child is arrested or detained.

THE DEEP DIVE

The legislation will:

- Require law enforcement to notify and contact parents or guardians in the event a child is arrested or detained;
- Require children to consult with legal counsel in person before they can waive their Miranda rights;
- Require all interrogation of a minor to take place with an appointed legal counsel physically present at the time of interrogation;
- Make inadmissible in any criminal prosecution brought by the U.S., any statement given by a minor during a custodial interrogation that does not comply with the requirements; and
- Defines a "minor" as an individual who is 17 years old or younger.

COMMUNITY-BASED GANG INTERVENTION ACT

THE PROBLEM:

Our nation currently locks up a far greater share of its youth population than any other developed nation. The overwhelming majority of these youth are held for non-violent crimes. Study after study has shown that the confinement of youth is ineffective in rehabilitating youth and extremely costly compared to evidence-based rehabilitative alternatives.

Community-Based Gang Intervention (CBGI) has been highly successful in states, such as California. CBGI identifies situations in which gang-related crime could result in revenge crimes, financial impacts on the families of the victims and alleged criminals and general deterioration to the community. Using intervention specialists, stops escalation of violence, while moving youth away from opportunities to join gangs.

However, a large majority of state spending on juvenile justice-related programs continues to go towards the cost of confining our youth while a minimal share goes towards delinquency prevention. Meanwhile, non-profit organizations and agencies dedicated to providing delinquency prevention programs such as CBGI continue to go underfunded.

THE SOLUTION:

The **Community-Based Gang Intervention Act** will allow the Office of Juvenile Justice and Prevention to provide funding and direction for agencies to intervene in the lives of young people who are at-risk, keeping them out of the prison system and making communities safer. By passing this bill, we can provide the necessary framework for communities and the government to work together to prevent gang violence before it begins.

THE DEEP DIVE

The legislation will:

- will help prevent and decrease youth gang violence; and
- continue landmark legislation that Congressman Cárdenas authored in the California State Assembly with then-assemblyman Congressman Adam Schiff, legislation that to this day provides millions of dollars across California for evidencebased gang prevention and intervention efforts.

ELIMINATING DEBTOR'S PRISON FOR KIDS ACT

THE PROBLEM:

Currently, most states and many localities continue to charge juveniles and their families fines and fees within the juvenile justice system. Many families cannot overcome the financial burden of compounding legal charges, which can have devastating effects for these families and their communities. The types of charges faced by these children and their families vary, but include things like: court expenses, fees for a public defender, fees for evaluation and testing, probation supervision fees and costs, fees for participation in diversion programs, treatment costs (including mental health treatment and rehabilitative programming), the cost of GPS monitoring, and the cost of care.

These costs create new obstacles for children and their families and are problematic when youth who would otherwise remain at home with their families may be incarcerated solely because they are unable to pay fees. This is true even when they pose no danger to the community and have no immediate need for services. Rather than improving public safety, this practice contributes to increased risks, as a report in Tennessee found that the imposition of fines and fees can significantly increase the likelihood of youth reoffending. Many of these juveniles are too young to have jobs themselves and can be pressured into committing crimes to pay off mounting legal fees.

THE SOLUTION:

The **Eliminating Debtor's Prison for Kids Act** will establish a grant program to provide meaningful resources for intervention programs to prevent juveniles' initial involvement in the justice system.

THE DEEP DIVE

The legislation will:

- incentivize states to terminate the harmful practice of using fines and fees in the juvenile justice system by providing grants to mental and behavioral health programs for at-risk youth;
- eliminate unnecessary and cumbersome fees and fines from the juvenile criminal justice system that can keep many families from falling deeper into debt;
